Executive Summary

- 1 A Deputy Commissioner of Police is a statutory role appointed by the Governor-General of New Zealand on the recommendation of the Prime Minister. There is currently one statutory Deputy Commissioner of Police. On 7 December 2022, the Cabinet Appointments and Honours Committee agreed to establish one or more additional statutory Deputy Commissioner of Police positions, and begin a process for recruitment [APH-22-MIN-0277].
- 2 Section 14 of the Policing Act 2008 states that the Public Service Commissioner is responsible for managing the appointment process for statutory Deputy Commissioners of Police, and for providing advice on nominations to the Prime Minister and Minister of Police. Subject to Cabinet agreement of the APH minute, advertising for the position will commence in December 2022.
- 3 We are seeking your review and confirmation of the draft Position Description (attached) for the statutory Deputy Police Commissioner role(s).

Te Kawa Mataaho Report: Deputy Police Commissioner Position Description

Background and Advice

- Deputy Commissioners of Police can be statutory, or non-statutory roles. When a statutory role, the Deputy Commissioner of Police is appointed by the Governor-General of New Zealand on the recommendation of the Prime Minister, for a term of up to five years. There is currently one statutory Deputy Commissioner of Police, whose term is due to expire in early June 2023.
- The Commissioner of Police has recently advised that retirements and vacancies to the Police Executive Leadership Team are expected in coming months. This provides an opportunity to ensure organisational stability by aligning the appointments process for the proposed Deputy(ies) with internal leadership changes and relevant portfolio delegations.
- The Commissioner of Police also considers having one or more of these roles appointed as statutory Deputy Commissioners, given the significant nature of the decisions they make in the course of their duties, would be beneficial in terms of supporting good governance, leadership and administrative practices within the New Zealand Police. A statutory Deputy Commissioner has important constitutional functions in additional to organisational leadership responsibilities, including:
 - 6.1 They may be designated as acting Commissioner in the event of the Commissioner's absence or incapacity, and hold all the powers, functions, duties, and responsibilities of the Commissioner; and
 - 6.2 They are uniquely positioned to ensure and uphold ethical standards, including by escalating any integrity issues (such as misbehaviour of the Commissioner) if required with the relative protections provided by statutory appointment.

Position Description

- 7 Deputy Commissioners of Police must be 'fit and proper persons' and credible, trustworthy leaders with wide organisational and operational experience.
- For these appointments, the Commissioner of Police has emphasised an in-depth understanding of how different aspects of policing interact, and expertise in deployment best practice, will be required to help manage demand and maximise policing resources and performance. The specific portfolio responsibilities for any statutory Deputy will be determined by the Commissioner of Police.
- The Position Description is the formal document against which an appointment is made and reflects the requirements of the role as set out by the Commissioner of Police. It has been drafted in consultation with the Commissioner of Police. You are invited to review and confirm the Position Description attached, that will be used in the appointment process for one or more statutory Deputies.

Appointment Process and Next Steps

- Section 14 of the Policing Act 2008 states that the Public Service Commissioner is responsible for managing the appointment process for statutory Deputy Commissioners of Police, and for providing advice on nominations to the Prime Minister and Minister of Police.
- On 7 December 2022, the Cabinet Appointments and Honours Committee considered a paper from the Minister of Police setting out the rationale for establishing a vacancy for one or more statutory Deputy Police Commissioners and confirming the Public Service Commission will begin the appointment

- process. The Committee agreed to establish one or more additional statutory Deputy Commissioner of Police positions, and begin a process for recruitment [APH-22-MIN-0277].
- 12 Subject to Cabinet agreement of the APH minute, advertising for the position will commence in December 2022.
- The Deputy Public Service Commissioner will consult with the Responsible Minister on persons to be appointed as interview panellists and will update the Prime Minister and Responsible Minister at key points throughout the appointment process. They will also provide a report regarding the panel's views of the suitability of shortlisted candidates for appointment in the new year.

Executive Summary

- In December 2022 Cabinet noted that under the Policing Act 2008 (the Act) the Governor-General may, on the recommendation of the Prime Minister, appoint one or more fit and proper people to the position of statutory Deputy Commissioner of Police [APH-22-MIN-0277].
- 2 Cabinet also agreed to establish one or more additional statutory Deputy Commissioner of Police positions.
- 3 Under section 13(2) of the Act, Deputy Commissioners of Police hold office at the pleasure of the Governor-General.
- On 28 March 2023, you received and accepted advice from Deputy Public Service Commissioner Heather Baggott that both Tania Kura and Jevon McSkimming are fit and proper people, and agreed to recommend to the Governor-General both people for appointment to the statutory role of Deputy Commissioner of Police for terms of five years.
- In the advice on 28 March 2023, we advised you that under section 15 of the Policing Act 2008, in the event of the Commissioner of Police's incapacity because of illness, absence, or any other cause the longest serving Deputy Commissioner is deemed to be appointed acting Commissioner until such

- time that the Governor-General, on the recommendation of the Prime Minister, appoints an acting Commissioner.
- With the recommendation to the Governor-General to appoint two Deputy Commissioners at the same time, there is potential confusion as to who is the longest serving Deputy Commissioner.
- After consulting with the Commissioner of Police, we have drafted the paper so that Deputy Commissioner McSkimming's term commences on 17 April 2023, and Deputy Commissioner Kura's term commences on 18 April 2023.
- We have also been advised that the Administrator of the Government will be making the appointments in the absence of the Governor-General. The paper and attachments have been drafted accordingly.
- 9 It has been the practice for the Government to advise the Leader of the Opposition of the appointments to this position before the appointment is announced. We recommend you consider continuing this practice.
- 10 A late lodgement of this paper has been requested.

Both appointees are currently non-statutory Deputy Commissioners at New Zealand Police.

About the nominees

Deputy Commissioner Jevon McSkimming has been a Police officer for 27 years, firstly in frontline roles, and more recently in organisation-wide roles shaping strategy, service delivery, arms administration, and ICT and infrastructure. In 2017 he was appointed Assistant Commissioner, Service, before being appointed (non-statutory) Deputy Commissioner, Strategy and Service in 2020.

Deputy Commissioner Tania Kura has been a Police officer for 35 years. She has worked up through the ranks to be Area Commander Hawkes Bay in 2012, and District Commander Eastern District (Hawkes Bay and Tairāwhiti) in 2017, before being appointed as (non-statutory) Deputy Commissioner Leadership and Capability in 2020.

The appointments commence of different dates as the Policing Act provides for the 'longest serving Deputy Commissioner' be deemed to be appointed acting Commissioner in the event that the Commissioner is incapacitated because of illness, absence, or any other cause.

To avoid any potential confusion as to which of the Deputy Commissioners would be the longest serving, the Prime Minister's recommendation is that Deputy Commissioner McSkimming's appointment commence on 17 April, and Deputy Commissioner Kura's appointment commence on 18 April 2023.

DEPUTY COMMISSIONERS OF POLICE: APPOINTMENTS

Proposal

This paper notes the Prime Minister's intention to recommend to the Governor-General that both Tania Ruth Kura and Jevon Murray McSkimming be appointed as a statutory Deputy Commissioner of Police, for five year terms.

Background

- In December 2022 Cabinet noted that under the Policing Act 2008 (the Act) the Governor-General may, on the recommendation of the Prime Minister, appoint one or more fit and proper people to the position of Deputy Commissioner of Police [APH-22-MIN-0277].
- 3 Cabinet also agreed to establish one or more additional statutory Deputy Commissioner of Police positions.
- 4 Under section 13(2) of the Act, Deputy Commissioners of Police hold office at the pleasure of the Governor-General.

Requirements for the Position

- The statutory requirement for the position is that the appointment be of a fit and proper person (s13(1) the Act).
- To be a fit and proper person for this role, we consider the incoming Deputy Commissioners of Police need to be honest and trustworthy, and have strong, credible experience in Police, with a good understanding of the role and work of New Zealand Police.
- Although the Deputy Commissioner position is statutorily independent of the Commissioner's position, under section 17 of the Act, the Commissioner of Police may delegate specific powers, functions and duties to fit their requirements. This delegation could be incorporated into any wider portfolio responsibilities to be determined by the Commissioner of Police following appointment and may change from time to time to meet changing priorities.
- 8 Under section 15 of the Act, in the event of the Commissioner of Police is incapacitated because of illness, absence, or any other cause, the longest serving Deputy Commissioner is deemed to be appointed acting Commissioner until such time that the Governor-General, on the recommendation of the Prime Minister, appoints an acting Commissioner.
- 9 Deputy Commissioners of Police must be able to 9(2)(a) privacy a Top Secret Special security clearance.

Recommended Appointees

- We propose the Prime Minister recommends to the Governor-General the appointment of both Tania Ruth Kura and Jevon Murray McSkimming to the role of Deputy Commissioner of Police, for terms of five years.
- Both appointees are currently non-statutory Deputy Commissioners at New Zealand Police.
- In order to avoid potential confusion as to which of the Deputy Commissioners would be the longest serving Deputy Commissioner and be deemed acting Commissioner should the Commissioner become incapacitated, the Prime Minister's recommendation is that Deputy Commissioner McSkimming's term commences on 17 April 2023, and Deputy Commissioner Kura's term commences on 18 April 2023.
- Deputy Public Service Commissioner Heather Baggott has advised that Deputy Commissioner Kura and Deputy Commissioner McSkimming are fit and proper people to undertake the role and they have the abilities to perform the elements of the role set out above. We have accepted that advice.
- Deputy Commissioner Tania Kura has particular strengths in policing operations having started her career as a general constable in Christchurch in 1988. She worked up through the ranks to be Area Commander Hawkes Bay in 2012, and then District Commander Eastern from 2017 before transferring to Police National Headquarters directly into the role of Deputy Commissioner Leadership and Capability in 2020.
- 15 Deputy Commissioner Kura 9(2)(a) privacy security clearance.
- Deputy Commissioner Jevon McSkimming brings a relatively unique career path within New Zealand Police. He has been a Police Officer for 27 years, but since 2010 Mr McSkimming has used his operational skills across the organisation to shape strategy, service delivery and resolutions, financial planning, arms administration, ICT and infrastructure. In 2015 Mr McSkimming was appointed to the role of Assistant Commissioner, Chief Information Officer, and in 2017 to the role of Assistant Commissioner, Service, before being appointed to his current role of Deputy Commissioner, Strategy and Service in 2020.
- Deputy Commissioner McSkimming 9(2)(a) privacy

 This is not seen as an impediment to Deputy Commissioner McSkimming's appointment.
- Attached are summary curriculum vitae for both Deputy Commissioner Kura and Deputy Commissioner McSkimming.

Remuneration

19 The remuneration for Deputy Commissioners of Police is set by the Remuneration Authority.

Appointment process and consultation

- Section 14 of the Policing Act 2008 provides for the Public Service Commissioner to manage the appointment process and to provide advice on nominations to the Prime Minister and the Minister of Police.
- 21 The process Deputy Public Service Commissioner Heather Baggott managed included the following steps:

- 21.1 Advertising the position through multiple channels from 19 December 2022 through to closure on 16 January 2023.
- 21.2 A shortlisting panel comprising the two Deputy Public Service Commissioners (Ms Heather Baggott and Ms Helene Quilter), Commissioner Andrew Coster, Commissioner of Police, and Deputy Commissioner, System and Agency Performance, Public Service Commission (Mr Thor Gudjonsson) reviewed all applications, and decided three applicants should proceed to the next stage.
- 21.3 Shortlisted applicants underwent an interview with the recruiter as to motivation for applying for the role, and an assessment centre exercise (including an assessment and interview with a psychologist, and an interview with a media specialist).
- 21.4 The Deputy Public Service Commissioner convened a Panel to assist her in the examination of applicants. The Panel comprised Ms Heather Baggott (Chair), Deputy Public Service Commissioner; Ms Helene Quilter QSO, Deputy Public Service Commissioner; Mr Andrew Coster, Commissioner of Police; Mr Brian Dickey, Partner, Meredith Connell, Crown Solicitor at Auckland, and Mr Steve Haami PSM, Kaihautū.
- 21.5 After deliberations, the panel agreed two applicants should proceed to the next stage of the process. This included detailed conduct and integrity checking, referee checks conducted with both nominated and non-nominated referees to provide a 360-degree view of both applicants.
- 21.6 The Deputy Public Service Commissioner provided advice to the Prime Minister and the Minister of Police on the nominations for the role.

Conflicts of interest

We can confirm that appropriate enquiries concerning conflicts of interest have been carried out, in accordance with the Public Service Commission appointment guidelines, to identify any conflict of interest that could reasonably be identified, and no conflicts of interest have been identified.

Timing and Publicity

Once the Governor-General has appointed Deputy Commissioner Kura and Deputy Commissioner McSkimming as (statutory) Deputy Commissioners of Police, the Office of the Minister of Police will coordinate the announcement.

Sensitive-Staff

Recommendation

- 24 It is recommended that the Committee **notes** the Prime Minister's intention to recommend to the Governor-General that:
 - 24.1 Jevon Murray McSkimming be appointed as the Deputy Commissioner of Police, New Zealand Police, for a five-year term commencing on 17 April 2023 and expiring on 16 April 2028; and

Deputy Commissioners of Police are appointed by the Governor-General, on the recommendation of the Prime Minister, for a term not exceeding five years, under section 13(1) of the Policing Act 2008. Under section 13(2) of the Act, Deputy Commissioners of Police holds office at the pleasure of the Governor-General.

The Cabinet has noted my intention to recommend that you appoint both Tania Ruth Kura and Jevon Murray McSkimming as Deputy Commissioners of Police under section 13(1) of the Policing Act 2008, for terms of five years.

Both Tania Kura and Jevon McSkimming are currently non-statutory Deputy Commissioners at New Zealand Police.

Deputy Commissioner Kura is currently Deputy Commissioner, Leadership and Capability at Police. Earlier in her career she had frontline and tactical roles, before rising to be the Area Commander for Hawkes Bay, and then District Commander in the Eastern Police District (East Cape to Hawke's Bay). She started her career in frontline roles in 1988.

Deputy Commissioner Jevon McSkimming has held organisation-wide roles shaping strategy, service delivery and resolutions, financial planning, arms administration, ICT and infrastructure. He started his career in frontline roles in 1996.

Summarised curricula vitae for both Deputy Commissioner Kura and Deputy Commissioner McSkimming are attached for your information.

The Minister of Police and I are of the view that both Deputy Commissioner Kura and Deputy Commissioner McSkimming meet the requirements of the Policing Act 2008.

I recommend that you appoint Jevon Murray McSkimming as Deputy Commissioner of Police for a term of five years commencing on 17 April 2023, and Tania Ruth Kura as Deputy Commissioner of Police for a term of five years commencing on 18 April 2023.
