I refer to your official information request received on 20 June 2024 where you have asked:

"I have a query in relation to the Michael Heron/Pania Gray lead inquiry into the use of census and health data by TPM.

Please can you provide me with a copy of the declaration of any conflicts of interest completed by Pania Gray".

Our response

To clarify, the inquiry in question is into how government agencies protected personal information provided for the 2023 Census and COVID 19 vaccination purposes. The purpose of the inquiry is to establish the facts and provide an independent assessment of government agency activity. It is not an inquiry into Te Pāti Māori. The terms of reference for the inquiry set out what is and is not in scope and are publicly available here.

Information being released

As with all inquiries, we request broad declarations from inquirers for Te Kawa Mataaho Public Service Commission to consider and when necessary, manage any perceived, potential, or actual conflicts of interest as appropriate.

For completeness, Pania Gray has provided the Commission with a range of her former and current associations to ensure any perceived, potential or actual conflicts of interests can be assessed. We have identified five emails from Ms Gray that contained information within scope of your request.

As the relevant emails also include information that is outside the scope of your request that would be redacted (including personal details about other individuals and administrative details about the inquiry) we have decided to release the relevant information to you in a summary form as enabled by section 16(1)(e) of the Official Information Act.

Please find outlined in the table below the declarations, concerning the government agencies, service providers and oversight bodies mentioned in the terms of reference for this inquiry Ms Gray has provided to the Commission.
