I refer to your official information request received on 22 August 2024 for:

All correspondence sent / received from other government agencies concerning announcements about organisation change occurring across public service agencies, since 27 November 2023."

On 17 September 2024, we notified you of an extension of time to make our decision to **17 October 2024**, due to your request requiring a search through a large quantity of information.

Publicly available

Listed in the table below are the reports provided to the Minister for the Public service outlining organisational change announcements across public service agencies. These reports include the information received directly from agencies concerning announcements about organisation change. As the information they provided is included in these reports, we have not included the communications from the agencies in the documents being released.
