Official Information Request
Ref: SSCOIA 2019-0057 (Part 2)

I refer to my letter of 11 June 2019, in response to your official information request received on 6 May 2019.

In my response to the last part of your request we noted that as we had not yet reached the 30 June 2019 deadline for compliance with the *Information Gathering and Public Trust* model standards, we were unable to respond to your query as information on which agencies were or were not compliant.

We committed to providing you with a list of agencies who have provided the State Services Commission (SSC) with their assurance that they are compliant with the new standards once it was available, and links to their transparency statements on their websites (or privacy statements where applicable).

Please find attached a table that provides the information as described above, noting that:

- the model standards stated that where agencies already publish privacy statements that meet the purpose of a transparency statement, the information did not need to be repeated. Therefore, some of these links will take you to previously published statements, especially where agencies have no regulatory or law enforcement functions, or only collect information via their websites.
- the model standards were issued using the Commissioner's powers under Section 57(4) of the State Sector Act 1988. Although the State Services Commissioner's powers do not extend to Crown Research Institutes, four have voluntarily provided assurance that they are compliant with the standards.
- no agencies covered by the model standards have failed to respond to the Commissioner's request to confirm their compliance with the model standards.

Please note that we intend to publish this letter (with your personal details removed) and the attached table with our response to you OIA request on the SSC website.
