I refer to your official information request received on 21 November 2024 where you asked:

“This email is to request if, in the interim, data for the year to June 2024 is now available please on the same basis ie excluding Tax Inspectors and Prison Officers.”

Information being released

Please find outlined in the below table, Public Service FTE data for inspectors and regulatory officers by number and percentage, excluding Department of Corrections (Corrections) and Inland Revenue Department (IRD) inspectors and regulatory officers, since 2007.

Please note that when calculating the percentage for your previous official information request (OIA 2024-0069), we used the FTE number of Inspectors and Regulatory Officers in the Public Service excluding IRD and Corrections (as requested) but for the denominator, the total Public Service FTE figure was used, rather than the more appropriate figure of total Public Service minus IRD and Corrections. There are some very minor changes to the FTE number (+/-1) due to rounding.

The new percentage figures fully exclude IRD and Corrections.
